To date many European countries have already made significant inputs in crop wild relative (CWR) conservation planning with some of them having developed operational national CWR conservation strategies and others being at the final stages thereof. The development of the European PGRFA *In Situ* conservation Network is now being implemented through the H2020 Project Farmer's Pride but the project does not have sufficient funds to work in all European countries and so funding is required to ensure those countries currently uninvolved are able to identify, preparation applications to join and approve sites in their countries to join the European *in situ* PGRFA conservation network.

Currently, the integration of the national and regional CWR conservation strategies to create an integrated and functional CWR conservation strategy for Europe is of the highest priority for many European stakeholders. The most important move in the field after the implementation of ECPGR Activity "CWR Conservation Strategies" in 2016 was the approval of the EU H2020 project "Farmer's Pride". The project started on the 1st November 2017 and will run for three years. The overarching objective of the project is to establish a network of stakeholders and conservation sites that effectively coordinates conservation actions to safeguard the wealth of Europe's *in situ* plant genetic resources (PGR) and integrates the user community to maximize their sustainable use. One of the project activities aims to design and implement a network of European sites and stakeholders that conserves

the breadth of PGR diversity found *in situ*. It has been entitled the European Network for *In Situ* Conservation and Sustainable Use of Plant Genetic Resources. This is the landmark within the context of all *in situ* conservation activities implemented so far. Therefore, it requires a concerted input from a wider stakeholder range to arrive to well-based and widely approved decisions. The ECPGR thematic and crop specific working groups may provide expert resources for such endeavour. Thus, all members of the Wild Species Conservation in Genetic Reserves agreed to take part in a workshop with Farmer's Pride project partners with the objective to identify, preparation applications to join and approve sites in their countries to join the European *in situ* PGRFA conservation network. A wide range of participating experts is of utmost importance because there is no other regional mechanism to enable knowledge sharing and to open opportunities to establish multi-actor partnerships.

This Activity supports the achieving of ECPGR Objective 3 *To improve in situ conservation and use of crop wild relatives* by contributing to the output 3.3 *Integrated European strategy for CWR conservation produced* and the output 3.4 *National and European MAWP networks established*.

It could be justified by the ECPGR Concept for *in situ* conservation of crop wild relatives in Europe, which provides as follows: "Recommendation 1: European countries should nominate national Most Appropriate Wild Populations – Following national research, the ECPGR National Coordinators for each European country should nominate national MAWPs to the ECPGR *In Situ* and On-farm Conservation Network for inclusion in the European Integrated *In situ* CWR Network."

The selected partners are those who have expertise in the field, are not already associated with the project Farmer's Pride and are eligible for ECPGR funding. Each partner will contribute to the Activity in terms of sharing their general and specific knowledge reflecting their socio-economic, legal, geographical or crop specific contexts, but will ultimately nominate national CWR *in situ* rich sites to join the European Network.

**Stage 1 Pre-Meeting:** Farmer's Pride project coordinating team sends copies of a draft document with requirements for inclusion of select sites within the European PGR *in situ* conservation network to all Activity partners with the request to review it and nominate at least one site for inclusion into the network. Each Activity partner then makes their input into the draft document, as they see necessary, identifies a site for nomination and sends required data with the reviewed draft document back to Farmer's Pride project coordinating team.

**Stage 2 Meeting 1:** This is the first of the two core parts of the Activity, a joint workshop with the Farmer's Pride Project. Both, Activity and Farmer's Pride project partners, elaborating the reviewed draft document, approve its final version. Draft list of agreed regional (European) and national MAWPs for inclusion in the *in situ* network is prepared and approved. Recommendations for the National government agencies and authorities responsible for PGR conservation and utilization are prepared and approved.

**Stage 3 Between-Meeting:** Activity partners nominate sites for inclusion in the European *in situ* network. Partners keep communicating with Farmer's Pride Project coordinating team to solve any issues or questions arising about site nomination.

**Stage 4 Meeting 2:** This is the second of the two core parts of the Activity, a joint meeting with the Farmer's Pride Project. Activity partners attend the launch meeting of the Network providing input to the European Policy on *in situ* CWR conservation, and benefit from attending the Farmer's Pride Dissemination conference.


