Description of Activity

Describe the Activity (max. 500 words):

Since April 2014, the ECPGR *European Search Catalogue for Plant Genetic Resources* (EURISCO) is being transferred from Bioversity International, Italy, to its new host, IPK Gatersleben, Germany. The adaptation of the system to the new IT infrastructure requires both the actual EURISCO web application (search interface) and the backend (module for uploading national data sets by the National Focal Points, NFPs) to be largely revised. Moreover, the last EURISCO training workshops for NFPs were conducted in 2009.

We would like to take this as an occasion to revive the series of regional training workshops, starting with Southeastern Europe, focussing on the SEEDNet member countries which include the ECPGR members Albania, Bosnia and Herzegovina, Bulgaria, Croatia, Hungary, FYR Macedonia, Montenegro, Romania, Serbia, and Slovenia. SEEDNet is presently coordinated by Vladimir Meglič, without external funding. Alban Ibraliu, lecturer at the Agricultural University of Tirana, Albania, and member of ECPGR working groups, agreed to host the workshop and to act as the local organiser.

The NFPs who were not yet members of the Doc&Info WG (according to the ECPGR website of 12 September 2014) were informed that they belong to the WG, thus being eligible to participate in the training.

Besides the training for technical data uploading, we also consider it essential to include data quality and completeness. Individual NFPs will test uploading their National Inventories (NI), and receive responses from the system, and will get guidance on interpreting and utilising these responses to improve their data. We will also cover checking scientific plant names (Helmut Knüpffer, IPK), and an experienced NFP (e.g. CGN, NordGen) will report about the experiences gained while working with the new system. We are convinced that such a report will both improve the further development of EURISCO and increase the acceptance of the system by other NFPs.

A short-term goal of EURISCO is the extension by characterisation and evaluation (C&E) data. Depending on the status of its implementation at the time of the workshop, submission of C&E data to EURISCO may also be included in the training.

Interested participants will get the opportunity to present their National Collection.
