Existing Terms and Conditions of Hosting Fees for Phase X

- ✓ Approved by the Director of Finance and Corporate Services in 2018
- ✓ Validity: from 1J anuary 2019 to 31 December 2023

Summary:

- The Overhead rate for all ECPGR secretary direct expenses is 15.84%
- Overhead waived for EURISCO; equivalent value of Bioversity overhead (15.84%) was charged to EURISCO funds and this amount was allocated to cover part of the Facilities, and IT charges. Recovered amount generated by the charge applied to EURISCO funds was Euro 77K for 5 years
- No overhead for Facility and IT fees applies



Services offered by The Alliance to the Hosted entities through the charging of the hosting fees (1/2)

- Use of assigned office spaces and utilize all common areas, meeting rooms, common space, library, and common facilities.
 Staff recruitment and selection.
- Staff contracts administration including administration of salaries and benefits.
- Finance and Accounting, including budget, treasury functions and audit support.
- Facilitates the operations of the Hosted entity by providing all necessary and reasonable assistance.

 • Assistance in the areas of procurement, travel services, protocol,
- security, and courier/postage.
- Obtaining legal status in country for Internationally recruited staff and their dependents which includes privileges, immunities and in some cases, tax and customs duties exemptions, in accordance with Bioversity's Country Agreements with the Governments.



Services offered by The Alliance to the Hosted entities through the charging of the hosting fees (2/2)

• IT services as per details provided:

Computer & Peripheral Support

Includes provision and support to computer equipment, & services that enable networked printing, photocopying and document scanning, as well as equipment loan and rental.

Software Support

Support services for institutionally approved licensed/open-source software that allow the operation of the Alliance both at the end-user equipment level and on servers.

Networking & Connectivity

Includes Internet access, structured cabled networking, wireless networking and DNS Management.

Security & Access

Includes security services such as virus protection, encryption, privacy, data security, identity management solutions, access controls, audit and monitoring systems and services, among others...

Server, Data & Storage

Management of servers, databases and centralized storage on premise and in the cloud, includes services such as application hosting, server virtualization, infrastructure colocation, infrastructure as a Service (laaS) and platform as a Service (PaaS).

Research Computing

Technology resources to support innovative research, includes access to high performance computing, and processing servers for conducting computationally intense research.

- Costing analysis applying 2023 rates
- Alliance's Overhead, Facilities and IT rates rates updated annually following CGIAR methodology
- Annual increase of 10% committed for Years 2024,2025, 2026 and for 2027 and 2028 assumption which will be reviewed after 3 years
- Work with ECPGR Coordinator and Finance and Operations staff of the Alliance
- Renewal for 3 years OneCGIAR evolving reality
- Preferential treatment for ECPGR as long-time historical partner and collaborator
